Notification of Award (NOA) of L1 Rate towards the Empanelment for Implementation Support Agencies (ISAs) under the JJM, Meghalaya

The Office of the Chief Engineer, PHE Meghalaya, floated the **Notice Inviting Expression of Interest (EOI) vide no. No.MD/JJM/ISA/13/2020-21/1** on the 21st July 2020 of the Empanelment for the Implementation Support Agencies (ISAs) under the JJM, Meghalaya. The opening of the EOIs was conducted on the 21st August 2020 which was opened on the 21st August, 2020 as described in the EOI. 10 (Ten) bids were received from 10 ISAs, as per the following: -

The bids were evaluated by a **Tender Acceptance Committee** and after detailed deliberation and careful consideration the technical bids of 8 (Eight) Bidders were found substantially responsive and the Committee shortlisted and identified the following Firms:

as the **successful bidders** to be issued with the Limited Tenders for Financial Bids, towards the **Empanelment as Implementation Support Agency.**

Thereafter, the financial bids of the 8 Bidders were evaluated by a **Bid Evaluation Committee** as per the procedures laid down in the Tender Documents. Based on the detailed evaluation and findings presented by the Committee it was concluded that, only 4 Bidders have quoted for all the 11 Districts, 2 Bidders have quoted for 4 Districts only, 1 Bidder have quoted for 1 District only and 1 Bidder i.e. Natural Resource Management & Common wealth 453, 2nd Floor, Dynamic Center, Zone 1, M.P.Nagar, Bhopal has not submit Financial Bid as indicated in the Table below:-

It was concluded that Bidder No. 2- Adarsh Sarswati Mahila Shiksha Plot 5 HH Colony, Bambor Road District Tonk, Rajasthan, had submitted the lowest evaluated substantially responsive bid.

The summary comparison of the submitted Price Bids (with GST) shows that the lowest evaluated substantially responsive bid is Bidder No.2, as per the Table below:

- **M/s Adarsh Sarswati Mahila Shiksha**, has submitted the lowest bid both for each districts as well as the Grand Total which is INR **8,72,69,500** (Evaluated Bid Price for all 11 Districts - with GST).
- The lowest evaluated bid is lower that the remaining Bids by around 70.64% (L2) and 181.55% (L3).
- Considering the requirements, it was considered that the price quoted by **M/s Adarsh Sarswati Mahila Shiksha** amounting to INR **8, 72, 69, 500** inclusive of GST, to be the lowest evaluated bid.


The Tender Committee was held on the 20th of May 2021. After detailed deliberation and careful consideration, the Committee accepted the rate quoted by **M/s Adarsh Sarswati Mahila Shiksha Plot 5 HH Colony, Bambor Road District Tonk, Rajasthan** and declared it to be the **L₁ Rate** for carrying out the support activities under JJM Meghalaya.

However, the other three qualified bidders (*i. Kalpataru Gramodyog Samiti, Plot No.9, 2nd Floor, Shivanah Towerm Aditya Avenue, Airport Road, Bhopal-462030, ii. Agency for Sustainable Development Initiatives Church House, Mission Compound, Shillong and iii. Priya Communication Sansung Plaza 2 Floor, Ganeshguri-Guwahati-5*) can give their consent before 30th June 2021 at 12.00 PM, (in the format as attached herewith in **Annexure - A**) to carry out the support activities and matching the **L₁** rates, failing which it will be presumed that the Bidder is not interested to match **L₁** discovered rates and is not interested to get empanel as a Implementation Support Agency.
